## **Methodology:**

- Online search conducted February 2025 for each local authority, using search terms [local authority name] plus "contaminated land", "register", and "inspection strategy". Where a search engine found no relevant results, a local authority site search on "contaminat\*" was carried out for confirmation.
- Where a contaminated land inspection strategy was found, the URL and year of publication were initially recorded. Where an online reference to a strategy was found but no document URL identified, this was noted in column B.
- Where a standalone public register was found, this was noted in column C. Where the local authority provided a statement that there was no such statement as it would have no entries, or indicated other options to access the register, this was noted in column D. Column D also provides limited information on the format of any register.
- The number of sites separately identified in each register is recorded in column E. These figures are not necessarily directly comparable across authorities due to slight differences in the definition of what comprises an individual 'site'.
- The results of a separate process of requesting contamination information through the Freedom of Information system are recorded in column F. Where responses indicated known contamination not currently contained within an online register, these are shaded grey.
- Through this process, information on the number of sites with potential contamination including former industrial, landfill and extraction facilities was collated through a review of information provided on website pages, contaminated land inspection strategies, and FOI responses. Where these figures were available they are noted in column G. These figures may represent a wide range of risk profiles and are influenced by the availability and completeness of data so should not be taken as indicative of the areas most impacted by contamination but rather the potential scale of the issue.
